### 3. Persons who have resigned

The persons who have resigned from their assignments in the enterprise fill in their personal and address details here, as well as the assignments they are resigning from. When you report your own resignation from a trading partnership or a limited partnership we take for granted that the other partners have accepted and approved of your resignation. We do not check this before striking you off the register. A notification to Bolagsverket of your resignation from the enterprise may therefore not replace the approval of the other partners.

You do not have the right – at any time and without stating any reason – to leave the trading partnership or the limited partnership. This is based upon the fact that you have made an agreement with the other partners of the enterprise. If any partner wants to leave the enterprise, the agreement must be changed. This requires the consent of the other partners.

If you did not notify your resignation in a legitimate way you are still responsible for the enterprise. You may then at a trial in court still be considered a partner.

### 4. Other matters

### 5. Signature

All persons reporting their own resignation must sign the form. If you represent a legal entity, write the registration number after the clarification of the signature. The rest of the persons in the enterprise need not sign as we presume that they have accepted and approved of the resignation. Read more under item 3. Persons who have resigned.

Fill in when and how you have paid the fee. To enable us to match the fee with your application you must state the registration number when paying. The fee cannot be refunded once we have started the examination of your application.
